## **Huntsville International Airport Announces “Spring Fling Getaway” Sweepstakes to the Emerald Coast, Re-launch of “Fly BWI & DC Is Free” Campaign**

*Promotions tout airport’s two low-cost carriers – AirTran Airways & Vision Airlines*

**HUNTSVILLE, Ala., April 26, 2011** – Huntsville International Airport (HSV) today announced two promotions aimed at touting its low-cost carriers, AirTran Airways and Vision Airlines. AirTran Airways operates daily non-stop flights to/from HSV and Baltimore/Washington and Orlando while Vision Airlines offers non-stop service between HSV and Destin/Ft Walton Beach with service Monday and Friday.

The first HSV promotion, “Spring Fling Getaway” sweepstakes, is in partnership with Vision Airlines, Parkway Place, Madison Square Mall and Four Points by Sheraton Destin-Ft Walton. Two grand prize packages to the Emerald Coast will be awarded – each including four roundtrip tickets to Destin/Ft Walton courtesy of Vision Airlines and three nights’ hotel accommodations courtesy of the Four Points by Sheraton Destin-Ft Walton. Sweepstakes registration is available at Parkway Place customer service and Madison Square Mall main office during normal business hours. The contest ends May 11, 2011. Complete sweepstakes rules are as follows:

*Grand prize winners must be at least 21 years of age. Airfare vouchers are valid for roundtrip travel from Huntsville International Airport to Northwest Florida Regional Airport (VPS) on Vision Airlines. Airline and hotel vouchers are nonrefundable, nontransferable and not redeemable for cash. Vouchers will not be replaced if lost or stolen. Certain restrictions, fees and blackout dates may apply. Ground transportation not provided. All taxes are the sole responsibility of the winners.*

In addition to the “Spring Fling Getaway” sweepstakes, HSV is excited to re-launch its “Fly BWI & DC is Free” campaign. This campaign, which was initially implemented last fall with tremendous success, is designed to show travelers how easy it is to fly AirTran Airways from Huntsville to Baltimore/Washington International Airport (BWI) for trips to DC. Rules for obtaining MARC vouchers are as follows:

*While supplies last, HSV will provide free train service vouchers on the Maryland Area Regional Commuter (MARC) from BWI to DC. To receive the MARC vouchers, proof of an AirTran Airways reservation from HSV to BWI is required. Reservations must have been made April 25, 2010, or later. Proof of purchase must be brought to the Huntsville-Madison County Airport Authority office (2nd floor – terminal) Monday through Friday between 8 a.m. and 5 p.m. to pick up prepaid MARC train service vouchers. One MARC train service voucher will be issued for each weekday route of the itinerary up to a maximum of two vouchers per passenger. Each voucher is good for one-way travel between BWI and DC – Penn Line only. The MARC operates Monday – Friday\* (no weekend service). Promotion good while supplies last.*

*MARC Voucher Rules:*

*Multi-ride tickets are for the exclusive use of the person whose personal signature must be affixed on the back in ink or indelible pencil before tickets are good for passage. In consideration of the reduced fare at which this ticket was sold, its use shall be subject to the following conditions:*

- 1. Tickets are nonrefundable.*
- 2. Protect your ticket by signing in proper space. Neither refund nor replacement can be made in connection with lost, stolen or misplaced tickets. Fare paid in absence of ticket will not be refunded.*
- 3. Ticket must be presented to the conductor for each trip, or whenever requested.*
- 4. If presented by other than signed ticketholder or if any condition of this contract is violated, ticket becomes void and may be taken up by conductor and fare collected.*
- 5. Ticket will only be accepted for passage on trains designated and advertised to stop at stations named on the ticket.*
- 6. The right of the Company is conceded to change the time of arrival or departure or its trains or to diminish their number at its option.*
- 7. Refunds will be made in accordance with tariff regulations.*
